Filing of Summons to be Joined as Intervener

Please note that you will not be able to proceed to file the Summons if you do not bring the required documents listed in this letter.

You may download the forms from our website at www.syariahcourt.gov.sg. All forms must be printed one-sided only.

You may file a Summons at the Syariah Court to add a person (the proposed Intervener) who is not a party to any divorce proceedings but who has an interest in the proceedings. You may file the Summons if you are the proposed Intervener OR if you are a party to the proceedings and have obtained the consent of the proposed Intervener.

Service may be effected by ordinary service and must be done within 7 seven days after filing the application.
